Fire Guardians are appointed by the County pursuant to the provisions of the Forest and Prairie Protection Act. Fire Permits are required from April 1 to October 31.

Duties:

1. Issue fire permits to applicants when in the opinion of the Guardian the burning proposed by the applicant may be properly controlled.
2. A Guardian is not expected to take any action in the matter of an out-of-control fire except to ascertain that the respective Volunteer Fire Brigade has been called.
3. Until a Volunteer Fire Brigade arrives, a Guardian may act to organize any volunteer assistance at the scene of a grass or brush fire.
