## **Key Duties and Responsibilities:**

- Assessment: Oversee the County's assessment program;
   ensure property valuations are done in a timely manner and accurate assessment notices are issued.
- Leadership: As an effective leader with strong communication skills, lead the team who is responsible for preparing stable and fair property assessments.
- Representation: Represent the County and defend property assessment decisions at assessment review board hearings.
- Research, Data Analysis, Reporting Writing: Conduct market research; read, gather, interpret and analyze data. Prepare written reports accordingly.
- Overall Department Responsibilities: Respond to questions related to assessment and taxation problems encountered within the department, ensure the effective development and implementation of department initiatives and policies, collaborate with stakeholders to build understanding about assessment and tax matters, develop the annual budget for the department and monitor fiscal activity to ensure conformity.
