Policy Statement

Lacombe County Council recognizes that our people (Councillors and employees) are our greatest asset and critical to the organization's success. Lacombe County Council appreciates the commitment and value that long service Councillors and employees provide to the organization.

Guidelines/Procedures

- 1. County Council will host a social event to honour Councillors and employees for long service with Lacombe County.
- 2. The Public Relations Committee shall be responsible for organizing a recognition function.
- 3. All employees, retired employees being recognized, and their guests will be invited to attend the recognition function.
- 4. There will be no charge to Councillors, employees, or their guests to attend the recognition function.
- 5. For Councillors and full-time employees service includes the number of calendar years of continuous service with the County including periods of layoff and disability of less than 12 months and approved leaves of absence of less than 12 months. It also includes approved maternity/parental leaves (length of leave in accordance with Alberta Employment Standards).
- 6. For the purpose of determining years of service for full-time seasonal employees, partial years of service will be counted as a full year of service.
- 7. Positions in duration of four months or less (i.e. summer seasonal positions) are not eligible for recognition under this policy.
- 8. For the purpose of determining years of service for year-round part-time employees, years of service will be prorated accordingly to their part time status.
- 9. The long service recognition award may result in a taxable benefit pursuant to the Income Tax Act. The taxable benefit will be calculated in the pay period following the Long Service Recognition social event or will be on the employee's T4.
- 10. Councillors and employees providing long service to Lacombe County shall be recognized in accordance with the following guidelines:
