

# Agricultural Service Board keeps ag in the forefront at Lacombe County

Agriculture makes up a significant part of the industry, history and culture of Lacombe County. Last year, Council decided to increase its focus on agriculture by reinvigorating the Lacombe County Agricultural Service Board (ASB).

Previously, Lacombe County ASB issues were dealt with during Committee of the Whole and regular County Council meetings.

"Council wanted to put Agriculture front and centre because we understand the role that it plays in Lacombe County," said Councillor Brenda Knight, the Chair of Lacombe County's ASB and Vice Chair for the provincial ASB. "We want to support our agriculture community as best we can, but providing them with tools to assist with funding, farm transitions, environmental concerns, and safety (and beyond)."

To do this, Lacombe County Agriculture Department has been busy working with industry partners and neighbouring counties to bring a variety of extension events, including the following upcoming workshops:

## What is the Agricultural Service Board, and what is its role in the County?

Agricultural Service Boards act as advisory bodies to municipal councils on agricultural matters.

The Agricultural Service Board Act was passed in 1945 to provide local authority over Alberta's growing weed and soil deg-

radation problems. Over time, Counties and Municipal Districts across the Province established ASBs, up to a total of 69 today.

The first ASB meeting in Lacombe County (MD of Lacombe No. 64 at the time) was held on August 23, 1945. Since the Board's establishment, the Lacombe County ASB has provided recommendations and guidance to Lacombe County Council regarding weed control, agricultural pests, soil conservation and agricultural extension programming to support the agricultural industry and community within Lacombe County.

## How does the County's ASB operate?

The Lacombe County Agricultural Service Board (ASB) is made up of Council. Members of Agricultural Services are responsible for delivering ASB programming and support programming activities under the Weed Control Act, Agricultural Pests Act, Soil Conservation Act and Animal Health Act.

ASBs are supported at the Provincial level by the Ministry of Agriculture and Irrigation and, more specifically, the Agricultural Service Board Program.

# Wolf Creek sees positive relationships built through SRO program

Stories of helping a student through family struggles, or outreach to ensure another child can find a better path forward, to simply connecting with high fives in the hallway highlighted a report from Wolf Creek Public Schools' (WCPS) School Resource Officers (SRO).

Const. Michelle Wilzer, Lacombe Police Service; Barb Reaney, Director of Safe and Caring Schools, WCPS; Const. Lenny Wells, Ponoka RCMP; and Dave Lahucik, Lacombe County Peace Officer provided a program update to the WCPS' Board of Trustees Jan. 19.

In schools, SROs provide a number of servic-

es, through presentations and interactions with students. SROs are able to encourage positive, healthy recreational activities for children and youth, while they develop a deep understanding of the school culture, and of any issue in the school that may be putting students at risk.

"It's about creating a visible and positive image of law enforcement, while forging relationships with students," said Reaney.

An average day is spent between schools, as Wolf Creek has four SROs. They serve the Wolf Creek schools within their own community, but also at times attend Wolf Creek schools in communities that don't have an SRO, to ensure those students are also getting vital information on everything from vaping to drugs, personal boundaries to traffic law.

Wells, who serves Ponoka and area WCPS schools, said he likes to start the day in the high school to build those close relationships, but ensures he is interacting with kids at the elementary school level as well, adding those relationships are crucial.

"When they come to the high school for the first time, if we haven't done a good job with education (in elementary) then it makes it tougher to make those connections," said Wells.

The presence of an SRO also benefits in response to incidents as they occur, and how best to respond.

"They want to look at alternatives other than always laying charges. They don't want to have to ticket unless necessary," said Reaney. "They

look at other ways to grow awareness through strategies like restorative justice."

Restorative justice is an approach that aims to repair harm by creating opportunities between those who take responsibility and those harmed to address their needs following an incident.

"It encourages engagement and understanding of the harm caused and the path forward to make amends," said Reaney.

SRO presentations to students have recently focused on bullying and cyberbullying, but will move to vehicle safety in March and impaired driving in April. Beyond presentations, SROs routinely talk with students in the hallways, create encouragement through kindness bingo or positive ticketing for a kind deed, to handing out collectable 'Cop Cards' that help students learn more about their SRO and become familiar with them in the school.

"Our SROs are often something as simple as a high five in the hallway all the way to as vital as a pillar of support, a big brother or sister for a student who feels they have no one else to turn to," said Reaney. "This commitment to youth is phenomenal and our schools, our students and our entire communities are better served with their presence in the school."

Wolf Creek currently has SROs based out of Ponoka, Lacombe, Lacombe County and Blackfalds.

## South of Highway 11 (East of Haynes) Area Structure Plan

### BYLAW NO. 1384/23

Lacombe County is creating a new area structure plan for the lands south of Highway 11, east of Haynes. This Plan is intended to replace the South of Highway 11 Area Multi-Lot Country Residential Outline Plan adopted in 2001. This update ensures the County's planning policies are consistent and respects the needs and desires of the community. After two rounds of public engagement, a refined draft was presented to Lacombe County Council on February 9, 2023, and Council gave First Reading to Bylaw 1384/23.

Lacombe County is holding a public hearing to present the proposed Plan. The public hearing will allow members of the public to provide further input before the Plan is adopted

## **Canadian Firearms Safety Course coming to Lacombe County**




## Now being offered in Lacombe County!

April 1st, 2023, at the Lacombe County Offices – Highway 12 / RR274, just west of town, starting 9 AM.

Cost - **\$140.00** 

Available to all 12 years and older - minors are welcome to bring a parent. Call or text **Dan** at **825.439.5208** to reserve your seat.



First-time license applicants must pass the Canadian Firearms Safety Course before applying for a Possession and Acquisition License. Anyone 12 years or older can take the CFSC. People 12 to 17 years old can apply for a Minor's License which allows them to borrow and use non-restricted firearms.

## Topics covered in the course include

- evolution of firearms, major parts, types and actions
- basic firearms safety practices
- ammunition
- operating firearm actions
- safe handling and carry procedures
- firing techniques and procedures
- care of non-restricted firearms
- responsibilities of the firearms owner/user
- safe storage, display, transportation, and handling of non-restricted firearms

Anyone wanting to acquire restricted firearms must also take the Canadian Restricted Firearms Safety Course and pass the written and practical tests.

## Other details:

 This course is designed by the RCMP and admin-

- istered in Alberta by the Alberta Hunter Education Instructor's Association.
- Course length is nine hours including a half-hour lunch, but not including practical testing time.
- Students must bring a piece of photo ID. Bringing lunch is recommended.
- Course materials include a manual, copies of the written and practical exams, several pamphlets and an assortment of deactivated firearms and dummy ammunition. The firearms we use to demonstrate safe handling skills are incapable of being fired and are transported with discretion.
- Requirements I'll need either access to a large TV or a projector and a blank wall and seating adequate to the size of the class. A quiet environment is appreciated but not absolutely critical.

## The Instructor:

Dan Johnston has taught the CFSC since the inception of the program in 1995. He holds a Alberta Permanent Teaching Certificate, and has recently retired from NorQuest College after 27 years of teaching. His professional specialty is testing and assessment.

# Lacombe County supports Mirror Community Trail

At the January 26, 2023 Lacombe County Council meeting, Council approved the creation of a proposed trail, which was presented by the Mirror Community Network.

"Lacombe County is very excited to be able to provide this new amenity in the Hamlet of Mirror," said Lacombe County Reeve Barb Shepherd. "By supporting the creation of the Mirror Community Trail, we are working with our residents to build a new way to explore nature and live healthier lives."

The project was initiated in the fall of 2022 by the Mirror Community Network. They proposed to create a walking trail around the Hamlet of Mirror, with a trail north loop and a south loop on either side of Highway 50. Much of the trail route uses existing sidewalks and open spaces; however, select sections pass through undeveloped road allowances, which will require some work to be done for the walking trail to be functional. The project's startup will include brushing in select areas, installing wayfinding signs, and placing garbage bins and benches along the trail.

Crews will start brushing the trail route by the end of February. Before the trail construction begins, landowners who may be impacted by its development will be contacted to discuss the proposed work and to talk over any potential concerns

## **Lacombe County Brushing Program**

Lacombe County is responsible for maintaining our road allowances, which includes brushing trees and other vegetation to ensure safety for travellers.

Part of our winter brushing is done in preparation for road construction, but our primary focus is on the travelling public's safety. We maintain sight lines at intersections and rail crossings on a scheduled rotation.

Lacombe County ensures that roadways are clear, including tree and limb removal and brushing in back alleys, subdivisions and machinery roads. This work is done to minimize trees falling on roads - damaging

vehicles and equipment, and keeping our roads as safe as possible.





# REMINDER | Ice Fishing Hut Registration

Lacombe County is no longer managing the voluntary Take It Off Program on Gull Lake and Buffalo Lake, as Alberta Environment and Parks has made it mandatory to identify all ice shelters in the province.

All ice fishing shelters that are on the ice for more than 24 hours <u>must</u> be labelled (2.5 cm block letters) with WiN number or name and phone number. <u>Ice fishing shelters must be removed from the ice by March 31.</u>

By identifying your ice shelter you help to ensure that all ice shelters are taken off the lake by the end of the ice fishing season. This helps to protect the environment and ensure the safety of anglers and boaters.

## **Grain Bag and Twine Recyclers in Lacombe County**

Are you recycling your agricultural plastics and twine helping to promote agriculture sustainability?

Please ensure you are only recycling clean baler twine and/or grain bag plastic, to ensure all product is accepted for recycle. See the following instructions below.









NO feed bags ~ NO grain totes

NO silage plastic ~

NO bale wrap

## **Grain Bag Recycling**



#### Requirements:

- Agriculture producers who request grain bag recycling services must provide one individual on site, capable of assisting the rolling and collection operation.
- Grain bags **MUST BE FREE** of grain, mud, dirt debris, and
- To ensure used grain bags are eligible for recycling, grain bag collection services should be scheduled within one week of grain extraction.
- Grain bag collection services are offered free of charge.

At this time, Lacombe County is ONLY collecting grain bags. The grain bags will be rolled and collected directly at the farm sites for eventual delivery to a plastic recycling center in Alberta.

#### **Twine Recycling**



#### Requirements:

- 1. Shake Remove as much debris, snow or ice as possible. Excessively dirty twine may be rejected, or subject to a landfill tipping fee or additional charges at drop off.
- 2. Bag Place loose twine in a Clean Farms Twine Recycling Bag and tie bags to close. Please do not knot the twine. Clean Farms Twine Recycling bags are available free of charge at Lacombe County office or Lacombe Regional Waste Services Commission Transfer Sites.
- 3. Return Return to a Lacombe Regional Waste Services Commission Transfer Site during regular business hours.

#### **Details:**

Producers can pick up Clean Farms Twine Recycling Bags at the Lacombe County office and Lacombe Regional Waste Services Commission Transfer Sites during regular business hours. Twine will only be accepted if it is placed in the Clean Farms Twine Recycling Bag, and then brought to the

The world of fertil-

ways of feeding nutrients to a crop to help farmers overcome different crop production challenges.

Typically, agronomists breakdown fertilizer recommendations into three general categories;

- 1. Geography what is the soil, topography, climatic constraints.
- 2. Crop what is being grown? A broadleaf brassica such as canola, a grass like wheat, or a legume like peas?
- 3. End use Is the crop being grown for feed or for human consumption/ processing?

Once we have the answers to these questions, we can start to narrow down the

total quantity of each nutrient (N-P-K-S) required by the crop. The next step is to then determine the application timing to deliver each nutrient (N-P-K-S) to the plant's root system. This becomes the complex part to figure out.

Always keeping in mind the 4R's of Nutrient Stewardship, specifically the "Right Source" of the fertilizer product is really critical to achieving yield goals. Not all forms of a nutrient are equal. Where the industry has done a poor job of educating the consumers and farmers, is explaining that this pound of nutrient is not always equal to that pound of nutrient. Whether the product is liquid, granular, elemental, coated, or homogenous, can be the difference between your crop having a balanced diet and converting plants per square foot into bushels per acre. It's the old saying when interpreting nutrient levels on a soil test; "Just because the nutrients are there, doesn't mean they're available".

For example, comparing one pound of nitrogen in the form of Urea, versus Ammonium Sulphate, versus ESN, technically the nitrogen component is nutritionally equal. However, the Urea is less stable and could be subject to environmental losses before the crop roots reach it. The Ammonium Sulphate is a stable form of nitrogen but comes attached to a pound of

sulphur which may or may not be beneficial or cost effective. A pound of nitrogen in the form of ESN is only released from its polymer shell under the right weather conditions. To use a financial analogy, it's like having equity versus cash. Both are valuable, but the cash is liquid and available instantly. We want to build a fertility plan like a financial plan that is diverse enough to provide for the crop through the entire season – seedling, to vegetative, to reproduction.


To account for a crop's individual and specific needs, at each specific growth stage, agronomists will use all the fertilizer sources and products at their disposal to prescribe a balanced diet for the crop. For example, seed row blends are generally higher in phosphorus, not only for seedling root development early on, but also because the most commonly used form of phosphorus fertilizer is very immobile within the soil profile. So for roots to be able to find the nutrition they require, the placement of granular "Mono-Ammonium-Phosphate" has to be close to, or within the seed furrow at planting time. Whereas sulfur is very mobile in the soil profile, and it's in highest demand later in the season as plants switch their focus from vegetative growth to seed production. This is why agronomists don't include sulphur in most

seed row blends, but rather in the side band. Also, most sulphur products have "slow release" or "controlled release" technology so although the nutrient is applied during spring seeding, the sulfur doesn't become available to the crop until flowering when it's needed. An indirect benefit of this technology is that it also minimizes the number of passes the farmer has to make across the field and therefore cuts down on fuel consumption.

Micronutrients such as copper or boron are available in granular and liquid forms. Both forms have advantages and disadvantages depending on the objective. Granular micronutrients tend to be more concentrated and are typically part of a longer-term strategy to build up deficient soil levels. Whereas liquid micronutrients applied foliarly through the sprayer, offer a faster response to a visible plant deficiency. Both forms could even be used in conjunction to bring a more wholistic and diverse plant health solution.

Bottom line is that every fertilizer has its place, and if every place has its fertilizer, then there's no reason that with good planning we can't achieve our cropping goals for 2023.



## **WILD BOARS**

Feral pigs (also known as wild boar at large) are one of the most damaging invasive species in North America. Some folks are keen to hunt wild boar at large, but this is not a viable control option.

## PRUSSIAN CARP / GOLDFISH

Aquatic invasive species are non-native animals or plants that can cause economic or environmental harm in waterways where they are introduced. Prussian Carp, a type of wild goldfish, is a harmful aquatic invasive species and has recently been found in Alberta. The species invades aquatic ecosystems and

poses severe threats to aquatic habitats and native fish populations

DON'T LET IT LOOSE!! Never release aquarium or domestic pond water, plants, dead or live animals into water bodies. If you catch a Prussian Carp while fishing, kill it. It is illegal to use live bait fish in Alberta.

#### **FLOWERING RUSH**

Common aquaculture plants can become invasive if they are not native to Alberta. Wind and water can spread seeds and plant fragments beyond your garden, which creates new populations that can dominate ecosystems and ruin habitats for native species.

### Prevent the spread of flowering rush.

- 1. Never release aquarium or domestic pond water, plants, dead or live animals into water bodies.
- If you see flowering rush, report it to the Aquatic Invasive Species Hotline (1-855-336-2628) or use EDDMaps Alberta from your smart phone.

DO NOT pull or dig it, as small fragments can break off and start new


## PALE YELLOW IRIS

Pale yellow iris (also know as yellow flag iris) is a perenial forb introduced to North America as a pond ornamental plant. It reproduces both by seed and vegetatively by pink, freely branching rhizomes. These rhizomes are fast spreading and can out compete other plants for space.

Yellow flag iris is sold through garden centers and the internet. Do not purchase or grow this plant.

Pulling/cutting yellow flag iris repeatedly over several years can eventually kill plant. Digging is effective but can fragment rhizomes which can produce new plants, so be sure to remove as much plant debris as possible.

## **SEA BUCKTHORN**

Sea Buckthorn is not a native species to North America. It is highly invasive (especially in riparian areas) and displaces naturally occurring vegetation and wildlife. In September 2019, Lacombe County Council passed Bylaw 1299/19, which elevated Sea Buckthorn to a local Noxious Weed within Lacombe County.

Sea Buckthorn is often used as an orchard species. As an allelopathic plant, Sea Buckthorn releases growth inhibitors into the soil preventing the establishment of native plant species.



#### **HIMALAYAN BALSAM**

Himalayan balsam is an invasive herbaceous plant that was initially introduced to North America as a garden ornamental. Himalayan balsam is widely distributed across Canada and can be found in eight provinces. Himalayan balsam creates dense and tall stands that prevent native plants from establishing and reducing biodiversity. This plant is a prolific nectar producer and produces about 800 seeds per plant. This annual species can aggressively replace native perennial plants along riverbanks, leading to soil erosion.

Cutting the plan below the lowest node can help stop regeneration. Smaller infestations can be controlled by hand pulling.





## **Frequently Asked Questions**



## What is an intermunicipal development plan?

An intermunicipal development plan is a land use plan that seeks to foster collaborative land use planning between two or more municipalities. It encourages the municipalities to work together to advance their common interest and reduces future conflict. An intermunicipal development plan applies to the lands surrounding the boundaries of two municipalities.

A municipality's Municipal Development Plan (covered in the January County News edition) must be consistent with its adopted intermunicipal development plans.

## **Does Lacombe County have** any intermunicipal development plans?

Yes! Lacombe County has adopted 10 intermunicipal development plans. The areas covered by intermunicipal development plans in the County are shown in the map below.

## What does an intermunicipal development plan do?

The Government of Alberta requires that intermunicipal development plan address:

- Future land use potential within the plan area
- The manner of and the proposals for future development in the area
- The provision of transportation systems for the area
- The coordination of intermunicipal programs relating to the physical, social, and economic

development of the area

- Environmental matters in the
- Any other matter that the councils deem necessary

## Why does Lacombe County need intermunicipal development plans?

Lacombe County appreciates the merits of working cooperatively with our neighbouring urban, rural, and summer village municipalities. The intermunicipal development plan requires that each municipal government think about the interests of the greater regional community and coordinate growth and development in a manner that benefits all communities involved.

A strong intermunicipal planning framework is recognized in planning

practice as a prerequisite to robust regional planning. For instance, the creation of the Sylvan Lake Intermunicipal Development Plan brought together eight partner municipalities, including one town, two rural counties, and five summer villages, to plan for the future of the Sylvan Lake area. This project was recognized by the Alberta Professional Planners Institute in 2022 through the Planning Award of Merit! Such projects ensure that development in the area is thoughtful, safe, and planned for the future, while being consistent with the needs and desires of the local community.


What initiatives have resulted from intermunicipal development plans that have helped our region?

- Various initiatives to fund amenities and infrastructure in the urban municipalities surrounded by Lacombe County


## Intermunicipal Development Plans in Lacombe County

## SANDY POINT RESORT/SUNBREAKER COVE BOAT LAUNCH PAID PARKING

Iln 2022, paid parking was implemented for the summer season at Sandy Point Resort and Sunbreaker Cove Boat Launch. By resolution of Council the Lacombe County paid parking program for Sandy Point Resort and the Sunbreaker Cove Board launch will be maintained in its current form.

#### **CERTIFICATE OF RECOGNITION 2022 AUDIT**

Lacombe County participates in the voluntary Partnerships in Injury Reduction Program that awards a Certification of Recognition (COR) for the health and safety management system. 




