**General Information** 

If someone wishes to operate on County-owned land, they must first obtain a Licence of Occupation from the County. A Licence of Occupation is a legal agreement authorizing the temporary occupation and use of the County land for a defined time period, under certain terms and conditions. Depending on the type of development proposed on the land, an application for a Development Permit may also be required.

**COMPLETE THE ATTACHED REQUEST FORM** by printing clearly or filling out all of the required fields electronically. Please note that handsigned electronic signatures are accepted, but digital encrypted type signatures are not accepted.

### **INCLUDE A SITE PLAN** drawn to scale showing:

- the legal description of the property;
- the parcel dimensions;
- the location and use of all existing and proposed buildings with distances from property boundaries;
- the location of any water bodies and other drainage courses, existing or proposed storm water drainage works, treed areas, shelter belts and other physical features of the land to be developed;
- the existing and/or proposed access to the property;
- all easements, right-of-ways, and adjacent roads; and
- site grading and drainage (indicated with directional arrows) if you are changing the site grade.
