The County has developed the Business Recognition Program to celebrate the success of new and established businesses in our community.

This Program is intended to recognize businesses as follows:

- **NEW BUSINESSES** may be recognized with a ribbon cutting event. The businesses celebrated through this Program will receive a commemorative ribbon as a keepsake.
- **EXISTING BUSINESSES** may be recognized for achieving the following milestones:
 - 10 Years of Service: Lacombe County Certificate of Recognition
 - 25 Years of Service: Lacombe County Certificate of Recognition and Engraved Plaque commemorating 25 years of service
 - 50 Years of Service: Lacombe County Certificate of Recognition and customized framed aerial photo of the business location
 - Beyond 50 years of service within 25-year increments: Lacombe County Certificate of Recognition and customized canvas featuring a collage of the business history

To be eligible, the business must: (1) be based and operate within Lacombe County; (2) be in good standing with Lacombe County, including having all required approvals with applicable legislation, including a development permit, if required; and (3) land on one of the milestone years of service listed above or have started their business within 6 months of the ribbon-cutting event. The County may request additional information to verify eligibility.

All recognition through this program will also be acknowledged through Lacombe County social media, posted on the Lacombe County website, and will be featured in the County News.

Recognition of Long-Standing Businesses the application must be submitted between December 15 and February 15. New Business Start-Up applications must be submitted at least 30 days prior to event date.
