BYLAW NO. 1141/11

BEING A BYLAW OF LACOMBE COUNTY, IN THE PROVINCE OF ALBERTA, TO PROVIDE FOR THE DESIGNATION OF HAMLETS WITHIN THE BOUNDARIES OF LACOMBE COUNTY.

WHEREAS Section 59 of the *Municipal Government Act* allows a Council to pass a bylaw to designate an unincorporated community as a hamlet;

NOW THEREFORE the Council of Lacombe County, duly assembled, enacts:

1. TITLE

1.1 This bylaw may be cited as "Designation of Hamlets Bylaw".

2. **DEFINITIONS**

In this Bylaw:

- 2.1 "Act" means the Municipal Government Act, R.S.A .2000, Chapter M-26.
- 2.2 "Hamlet" means an unincorporated community located within the boundaries of Lacombe County, and;
 - a) consists of five (5) or more buildings used as dwellings, a majority of which are on parcels of land smaller than 1850 square meters,
 - b) has a generally accepted boundary and name, and
 - c) contains parcels of land that are used for non-residential purposes.
- 2.3 "County" means Lacombe County.

3.0 DESIGNATION OF HAMLETS

- 3.1 That the unincorporated community contained within the area outlined in red on the attached Schedule "A" shall be designated as the Hamlet of Joffre.
- 3.2 That the unincorporated community contained within the area outlined in red on the attached Schedule "B" shall be designated as the Hamlet of Morningside.
- 3.3 That the unincorporated community contained within the area outlined in red on the attached Schedule "C" shall be designated as the Hamlet of Tees.
- 3.4 That the unincorporated community contained within the area outlined in red on the attached Schedule "D" shall be designated as the Hamlet of Haynes.
- 3.5 That the unincorporated community contained within the area outlined in red on the attached Schedule "E" shall be designated as the Hamlet of Mirror.

4. REPEAL OF BYLAW

4.1 Bylaw 909/00 is hereby repealed.

5. EFFECTIVE DATE

5.1 This Bylaw will come into force and effect on the final day of passing and signature thereof.





SE-09-39-25-W4M HAMLET OF JOFFRE





NE-35-41-26-W4M HAMLET OF MORNINGSIDE




