- the parcel dimensions;
- location of the proposed sign(s);
- distance(s) to any highway(s) or road(s); and
- distance(s) to all property line(s).

INCLUDE A SIGN SKETCH OR PHOTO showing:

- dimensions of the sign face;
- wording;
- colours and finishes;
- supporting structure; and
- height above ground level.

A NON-REFUNDABLE PROCESSING FEE must also be paid at the time the application is made. The current fee is \$50 for a sign application. All fees are payable to Lacombe County via cheque, cash, debit, or credit card. Credit card payments are completed using OptionPay (a third party software provider) and are subject to additional surcharges.

MORE INFORMATION may be requested by the County to properly evaluate the application.

PLEASE NOTE no work is to begin on the construction and installation of the sign(s) until the County has issued a permit.

OTHER APPROVALS MAY BE REQUIRED. A permit will also be required from Alberta Transportation for any sign to be located within 300 metres (984 feet) of a provincial highway right-of-way boundary or within 800 metres (2625 feet) of an intersection of a provincial highway with another public road.
