

## Farewell from Reeve Barb Shepherd

A reflection on 12 years of learning, leading, and sisterly lessons in government.

When I was elected to Lacombe County Council in October 2013 to represent Division 3, I had no idea how much I would learn — or how little I really knew about local government.

To the residents of Division 3, thank you for placing your confidence in me for the past 12 years. It has been a privilege to serve and represent you.

## LEARNING TO FIND MY PLACE IN THE FAMILY OF GOVERNMENT

If I could describe municipal government in one phrase, it would be: the little sister in a family of three

At the top, the federal government — the "big sibling" who makes the grand decisions and often gets the attention. In the middle, the province — the "big sister," who sets most of the rules, takes the lead on big-picture issues, and sometimes forgets to check in with her younger sibling. And

then there's us — municipalities — the little sister who does her best to keep the household running smoothly.

We're responsible for the roads and bridges people drive on every day, the water that flows in and out of many of our industrial and commercial parks, and the parks and playgrounds that families enjoy. We collect property taxes, not just for ourselves, but also for education, senior housing, and policing on behalf of our "big sister."

But unlike our older siblings, we can't borrow for our operating needs or run a deficit. Our allowance — property taxes — has to stretch to cover it all. And even when we cry, pout, or plead for change, we're often reminded who makes the rules. Sometimes, we get a pat on the head. Other times, we're told to "figure it out." Over the years, I've learned that sometimes being the little sister means learning to work twice as hard to be heard.

#### **CANDIDATE INFORMATION**

#### **ELECTION DAY VOTING STATIONS**

Election Day is October 20, 2025. There is a possibility that not every division in Lacombe County will necessarily have an election this year, for example, if only one person is running for office in a division.

Once nominations close and candidates are confirmed, we will share a complete list of Election Day voting stations.

#### **VOTER ELIGIBILITY**

You are eligible to vote in the election if:

- You are at least 18 years old,
- · You are a Canadian Citizen, and
- You reside in Alberta, and your usual place of residence is located in the local jurisdiction on election day.

#### **VOTER ID REQUIREMENTS**

All registered voters are required to show valid government issued identification containing the voters name and photograph.

#### **GROWING PAINS AND TOUGH LESSONS**

One of those "big sister" moments came when the Province required all municipalities — urban and rural alike — to develop Intermunicipal Collaborative Frameworks. These agreements were meant to define how neighbours would "play nice in the sandbox" by sharing services and revenue. For Lacombe County, that meant 15 separate agreements.

Like any little sister, we rolled up our sleeves and got it done — on time and in good faith — even as many others across Alberta struggled to meet the deadline.

Then came the issue of unpaid property taxes from oil and gas companies. When our big sister sided with industry, it left many rural municipalities struggling with millions in unpaid taxes. While Lacombe County was fortunate compared to others, the experience was a reminder that the family dynamic doesn't always feel fair — and that even when you're right, sometimes the bigger sibling's voice carries louder.

The debate about creating a provincial police force was another example of this sibling push and pull. Over the past 12 years, I've seen the relationship between municipalities and the RCMP improve dramatically. County Council now meets regularly with K Division leadership and local detachments — something that would have been unthinkable years ago. Perhaps, in this case, big sister's idea had some merit.

And then there's fire protection — something municipalities aren't even required to provide under the Municipal Government Act, yet nearly all do. It's a vital, costly, and increasingly complex service. Our firefighters are no longer volunteers, but "paid on-call" professionals who meet provincial standards and face strict rules for training and equipment. Once again,

big sister sets the bar, and little sister works tirelessly to meet it — because keeping our residents safe matters most.

#### WHAT I'VE LEARNED FROM FAMILY

Through it all, I've learned that being the "little sister" has its advantages. We're close to the people we serve. We're nimble. We adapt quickly. And we care deeply about doing what's right for our communities.

I've had the privilege of working alongside councillors who share that same commitment – people who debate passionately, listen openly, and, in the end, come together for the good of the whole family. We haven't always agreed, but we've always respected one another and focused on what unites us rather than what divides us. That's the true strength of local government.

To my fellow councillors — past and present — thank you for the collaboration, the challenges, and the camaraderie. I've learned so much from each of you.

## GRATITUDE FOR THE TEAM BEHIND THE SCENES

To the incredible staff of Lacombe County — thank you. You're the unsung heroes who make it all work. Every day, you show up ready to serve, solve problems, and take on challenges — even when you're the ones answering for decisions you didn't make.

Whether you've been here for decades or just joined the team, I see the same dedication and pride in every corner of the organization. You are the reason the County continues to thrive.

#### THE JOURNEY AND THE JOY

The past 12 years have been some of the most challenging, rewarding, and fulfilling years of my

life. Serving as Reeve for the past four years has been an incredible honour.

One of my greatest honours has been celebrating the Farm Family of the Year recipients—families who truly embody the heart and spirit of rural Alberta. This award holds special meaning for me, as it offers the opportunity to connect with the people who form the backbone of our community.

Chairing nearly 100 meetings certainly tested my patience (and my stamina!), but it also gave me opportunities I'll cherish forever. This includes representing the County to receive the Alberta School Boards Association (ASBA) Zone 4 Friends of Education Award in November 2024 for our support of the Wolf Creek Public Schools (WCPS) social worker and School Resource Officer (SRO) programs, hosting international ambassadors on a bus tour of Lacombe County, attending the opening of the Burns Nature Park.

And as fate would have it, my final event as Reeve was the grand opening of Dairy Innovation West — a project six years in the making, and a perfect reminder that great things take time, teamwork, and trust.

#### THANK YOU, LACOMBE COUNTY

As I step away from municipal life, I do so with deep gratitude — for the lessons learned, the people I've met, and the memories made.

Being the "little sister" hasn't always been easy. But it's made us resilient, resourceful, and I'm proud of the role local government plays in shaping our everyday lives.

Thank you, Lacombe County — for letting me be part of this family. It's been an honour to serve you.

## (Cont. from front) Municipal Elections 2025

#### Samples of common identification:

Alberta Drivers Licence, Canadian Passport, Canadian Citizenship Card, Canadian Forces ID card, Veterans Health Care ID card, First Nation Membership card, Métis Nation of Alberta Citizenship card.

All non-registered voters will be required to complete a statement of elector eligibility and show valid government issued identification containing a photograph, name, and current physical home address. If unable to produce government issued photo identification, you'll be required to provide valid ID with your name and address (showing your physical home address), such as a bank statement, personal cheque, mortgage statement, income tax assessment or vehicle ownership/registration.

#### WHY MUNICIPAL ELECTIONS MATTER

Municipal governments play a direct role in your daily life. They are responsible for services such as road maintenance, snow removal, water distribution, municipal planning and development, fire services, parks and trails, bylaw enforcement, and property taxes. The decisions made by the County Council shape the future of our communities and affect how services are delivered.

By casting your ballot, you are helping to choose the leaders who will make decisions about the services and infrastructure you rely on every day. Your vote ensures your voice is heard in shaping the future of Lacombe County.

# Do you have outstanding 2025 taxes?

# November 30 deadline fast approaching; 10% penalty will be applied to all unpaid taxes

An additional 10% penalty will be added on December 1 for all taxes unpaid after November 30, 2025.

The November 30 deadline and penalty are not applicable to property owners currently enrolled in the Tax Installment Payment Plan (TIPP).

#### How can I pay my taxes?

Tax payments are payable to Lacombe County and can be made using one of the following options:


- By mail to: Lacombe County, RR3, Lacombe, AB T4L 2N3
  - Mailed payments must be postmarked by Canada Post no later than August 31st of the current year. If the postmark is illegible or missing, the actual date of receipt by Lacombe County will apply.
- In Person: At the County Office (40403 RGE RD 274, Lacombe County, AB) during office hours (8:00 a.m. 4:30 p.m.)
  - Deposited in the envelope mailbox located at the road entrance to the County office (do not submit cash).
- Through Your Financial Institution: Payments can be made at most financial institutions through internet or telephone banking.
  - Set up Lacombe County as a bill payee using roll number for taxes, utility account number for utilities.
  - Each roll and utility account number needs to be set up individually, or payments may be misapplied.
- Electronic funds transfer (EFT): Businesses, please contact the office if interested in paying by EFT
- By Credit Card: visit www.lacombecounty.com and pay through OptionPay, a secure third-party site, to make payment by credit card. (Please note that there is a fee for this service. Lacombe County does not receive any of the credit card fees.)

**Tax Installment Payment Plan:** Those enrolled in the County's tax installment plan (TIPP) will see their payment adjusted, annually in May to reflect the new tax rates for the current year.

You can pay your bills through the teller service, bank machine, internet or telephone.

**Please Note**:To ensure your payments are credited to your account, please remember to include the top "tearaway" portion of your assessment and tax notice, or provide your 10 Digit Tax Roll Number with your payment.

If you are paying by cheque, please make it payable to Lacombe County.

## We want YOU! Consider being a firefighter

As the school year begins and with Fire Prevention Week approaching, Lacombe County is putting out a call for new paid-on-call firefighters to bolster its fire departments. The need is especially pressing in the communities of Alix, Eckville, Bentley, and Clive, where daytime coverage is essential.

Dave Bain, the Manager of Fire and Emergency Services for Lacombe County, emphasizes the importance of local involvement, noting that having a strong, community-based fire service is crucial to maintaining safety and rapid response times.

Interested in giving back to your community, being part of a well-trained team, and taking on an exciting challenge? Consider joining Lacombe County's fire services as a paid-on-call firefighter. This role offers a unique opportunity to make a real difference in your community while developing valuable skills and working alongside a dedicated team.

Lacombe County's fire services rely on individuals who can respond quickly to emergencies and to increase the number of trained members to meet the growing demands of the community. The County is particularly interested in recruiting people who are available during the day when many current members are unavailable due to work commitments outside their communities

The County encourages individuals available during daytime/school hours to consider joining the fire services. This includes:

- Individuals who work from home
- · Stay-at-home parents
- Freelancers
- · Remote employees
- Entrepreneurs running a home-based business

Their participation could provide a valuable boost to our local fire departments.

Requirements to become a paid-on-call fire-fighter include:

- · Being 18 years of age or older
- Holding a valid class 5 driver's license
- Maintaining physical fitness
- Living or working within the response areas in/around Alix, Eckville, Bentley, or Clive

In addition to these requirements, paid-on-call firefighters are expected to attend at least 50% of the scheduled training sessions and be available to respond to 25% of the emergency calls.

# Lacombe County Fire Services urges residents to know the risks of lithium-ion batteries

October 5-11, 2025 is National Fire Prevention Week, and this year's theme is "Charge into Fire Safety™: Lithium-Ion Batteries in Your Home." It highlights how important it is to buy, charge, and recycle lithium-ion batteries safely.

Most of the electronics we use in our homes every day — smartphones, tablets, power and lawn tools, laptops, e-cigarettes, headphones, and toys, to name just a few — are powered by lithium-ion batteries. In fact, most everything that's rechargeable uses this type of battery.

If not used correctly or if damaged, lithium-ion batteries can overheat, start a fire, or even explode. To reduce these risks, look around your home — it's important to know which devices are powered by them. "Lithium-ion batteries are powerful, convenient, and they're just about everywhere," said (your name, title).

This year's Fire Prevention Week campaign helps people understand the importance of using these batteries correctly to prevent fires in the home and to follow the Buy, Charge, and Recycle Safely approach."

#### **BUY ONLY LISTED PRODUCTS.**

- When buying a product that uses a lithiumion battery, take time to research it. Look for a stamp from a nationally recognized testing lab on the packaging and product, which means that it meets important safety standards.
- Many products sold online and in stores may not meet safety standards and could increase the risk of fire.

#### CHARGE DEVICES SAFELY.


- Always use the cords that came with the product to charge it. Follow the instructions from the manufacturer.
- If you need a new charger, buy one from the manufacturer or one that the manufacturer has approved.
- Charge your device on a hard surface. Don't charge it under a pillow, on a bed, or on a couch. This could cause a fire.
- Don't overcharge your device. Unplug it or remove the battery when it's fully charged.

#### RECYCLE BATTERIES RESPONSIBLY.

- Don't throw lithium-ion batteries in the trash or regular recycling bins because they could catch fire.
- Recycling your device or battery at a safe battery recycling location is the best way to dispose of them. Visit call2recycle.org to find a recycling spot near you.
- Lacombe Regional Waste Services Commission accepts all batteries at our sites for recycling. Please ask the attendant where batteries can be safely placed. Do NOT place batteries in the Rubble Bins or the Compactor Hopper (see Page 22 for more details).

Lacombe County Fire Service encourages all residents to be aware of their devices, follow the Buy, Charge, and Recycle Safely approach, and support this year's FPW theme, "Charge into Fire Safety $^{\text{TM}}$ ."



#### **Mirror Dog Tags**

A license is required for all dogs in Mirror \*\*NEW\*\* Lacombe County has introduced a more flexible dogtag licensing system for residents of Mirror. Any new licenses issued will be valid for the lifetime of the dog. Existing licenses will remain valid until renewal, at which point dog owners must obtain a lifetime tag under the new structure.

Lifetime license fees:

- \$25 Dog that is both altered and microchipped
- \$75 Dog that is either altered or microchipped
- \$150 Dog that is unaltered and not microchipped
- \$15 Replacement dog tag

If you receive a violation notice under the Dog Control Bylaw, you can pay it within 30 days to receive a 50% discount; after that period,

the full penalty applies.

To order your new tag or view full bylaw details, visit lacombecounty. com/dogcontrol or call 403-782-8959

Lacombe County will issue a tag for each dog, which must be attached to a collar worn by the dog at all times. Lacombe County Enforcement Officers will do checks to ensure compliance.

Construction on the Fairview Cemetery Expansion Project will resume this


Construction in the northeast section of the cemetery will include:

# Fall is the best time to test for radon

As the weather cools and we begin closing up our homes for the season, now is the perfect time to test for radon.

#### WHAT IS RADON?

Radon is a colourless, odourless, radioactive gas that comes from the natural breakdown of uranium in soil and rock. It can enter homes through cracks in foundations, sump pumps, drains, and other openings. Because it is invisible and has no smell, the only way to know if your home has radon is to test for it.

#### WHY TEST IN FALL AND WINTER?

When our windows and doors are closed, radon is more likely to accumulate indoors. This makes the cooler months the most accurate time to test. Health Canada recommends testing for a minimum of three months between October and April.

#### WHY DOES IT MATTER?

Long-term exposure to high levels of radon is the second leading cause of lung cancer in Canada after smoking.

Testing your home is simple, inexpensive, and could protect your family's health.

#### HOW TO TEST:

- Purchase a do-it-yourself test kit (available online or at many hardware stores).
- Consider hiring a certified radon professional.

If high levels are found, mitigation systems are available and effective.

Protect your family this fall—make radon testing part of your seasonal routine.

## **Clubroot of Canola**

#### What is it?

Clubroot is a serious soil-borne disease of canola, mustard, and other crops of the cabbage family.

#### Why is it of concern?

This disease is capable of significantly reducing yield, quality, and may destroy a crop if infestation is high enough.

#### How can it be spread?

Infested soil can be carried field to field by farm machinery especially tillage equipment, as well as wind and water erosion.

#### How long can it persist in the soil?

Resting spores are extremely long lived and may survive in soil for up to 20 years.

#### **Best Management Practices**

- Use Clubroot resistant varieties when growing canola in areas only where the disease is established.
- Use long rotation breaks (Three years or more) between canola crops.
- Practice good sanitation of equipment and machinery to restrict the movement of potentially contaminated soil.
- Use direct seeding and other soil conservation practices to reduce soil erosion
- Minimize vehicle and equipment traffic to and from fields.
- Scout canola fields regularly and carefully.
   Identify causes of wilting, stunting, yellowing, and premature ripening.

#### **Lacombe County Clubroot of Canola Inspections**

Lacombe County Agricultural Service Board will be conducting random Clubroot of Canola Inspections as per County Policy AG(11) Clubroot of Canola.

With the increased spread of Clubroot of Canola within Central Alberta, canola growers must remain vigilant to limit the spread and minimize the economic impacts of Clubroot of Canola.


Symptoms include patches of premature ripening plants, shrivelled unfilled seed pods, and galls present on the plant's root system.

Swathing operations provide an excellent opportunity to scout for the presence of Clubroot of Canola, as well as sclerotinia, and blackleg. If you spot patches of prematurely ripened Canola in your field, take a minute to pull some standing plants or stubble and inspect the root system.

## How to convert a low-yielding "Low Spot" in your field, to a \$100/acre/year (net) ALUS project

Maybe this year, after an "average" rainfall season, you noticed again those low spots in your fields, that yielded poorly during harvest.

Those areas could be costing you money. Research continues to try to figure out just how much. For example, see the work being done right now at Olds College (Scan the QR code for details)



#### As research

continues, you likely already know some of the marginal areas in your crop fields that cost you money.

You could decide to change these acres from marginal crop producing, to producing increased ecosystem services, apply to enroll them in ALUS, and get paid for them: up to \$100 / acre

Some options to consider for these marginal areas include:

Low spots that dry out in a few days / weeks: simply farm around them: turn off the equipment, drive around if you have to, leave a little "space for nature" (see photo). Or, if you need to, seed them to native (or tame) forage, that is tolerant of the soil and moisture conditions found there.



An ALUS-enrolled ephemeral wetland in a bean field in Red Deer County. This wetland is providing ecosystem services like water storage and infiltration, and wildlife habitat.

- Areas around permanent / semi-permanent water bodies that are often too wet / soft to get equipment in: seed them to native or tame forages, to create a buffer between your good cropland and the water body
- Planting native flowering plants for habitat / food for our native pollinators like bumble-
- Planting native trees and shrubs like willows to enhance habitat for wildlife.

If you want to do things like this with ALUS, you can also apply for 50% of the total value of 'establishing" these projects. This means you could get 50% of the value back from ALUS, for seeding the forage, planting the trees, etc. This "establishment cost share" is over-and-above the ALUS annual payments.





#### **Details:**

This service is offered free of charge to agriculture producers operating within Lacombe County. The grain bags will be rolled and collected on farm site for eventual delivery to a plastic recycling center in Alberta.

#### **Requirements**:

- Agriculture producers who request grain bag recycling services must provide one individual on site, capable of assisting the rolling and collection operation.
- Grain bags **MUST BE FREE** of grain, mud, dirt debris, and vermin.
- To ensure used grain bags are eligible for recycling, grain bag collection services should be scheduled within one week of
- Grain bag collection services are offered free of charge

#### **Twine Recycling**



#### **Details:**

Producers can pick up Clean Farms Twine Recycling Bags at any Lacombe Regional Waste Services Commission Transfer Site during regular business hours. Twine will only be accepted if it is placed in the Clean Farms Twine Recycling Bag, and then brought to the collection site.

#### Requirements

- 1. Shake Remove as much debris, snow or ice as possible. Excessively dirty twine may be rejected, or subject to a landfill tipping fee or additional charges at drop off.



## **Central Alberta Foodgrains Growing Project**

The local growing project completed its 30th harvest on its field northwest of Bentley along Highway 20 on Saturday, September 27.

Six combines harvested the 72 acre canola field in 2 1/2 hours. Two grain trucks supplied by Vision Truck Lines hauled the canola to the Richardson Pioneer elevator just east of Lacombe where it was sold.

The canola was graded #1 and the local project received a cheque in the amount of \$37,353.46. As well \$860.00 in donations was received on the Saturday.

Prior to the harvesting, a free lunch was provided to the volunteers and 100 people in attendance. The pizza lunch was provided by Decisive Farming. Farm Credit Canada and P&H contributed coffee and donuts. GEM Silage supplied water, plates, and tables.

The growing project started in 1996 by six Lacombe County farmers is one of the oldest in Alberta. Now in its 30th year, the local committee consisting of 12 members has had incredible support from farmers, landowners, agribusinesses, the media and donors.

Some Lacombe County farmers also donate a portion of some of their own crops and designate it to the local project at local elevators.

All funds gathered by December 31 are sent to the Canadian Foodgrains Bank in Winnipeg to help feed hungry people internationally. For the year ending March 31, 2025, the Foodgrains Bank helped 1,176,111 people in 37 countries. Cash donations are eligible for an official tax receipt.

"We are already starting the process to secure

land for 2026," says committee member Doug Maas. "Some years the land is donated to us to grow a crop, and in some years we pay cash rent. We are appreciative of whatever the arrangement happens to be."

## **Unsightly Properties**

WE HAVE ANSWERS



It's October, which means pumpkins, costumes, and spooky decorations are popping up across Lacombe County! Halloween is meant to be fun and festive—but an unsightly property can scare your neighbours for all the wrong reasons. Unlike cobwebs on your front porch, an unkept yard or deteriorating building isn't festive.

This month, we're answering a common question we hear: What exactly is "unsightliness," and what are the County's rules around it?


#### WHAT IS CONSIDERED "UNSIGHTLY"?

Alberta's Municipal Government Act gives us the official definitions:

- Unsightly structure: A building or structure that shows significant physical deterioration.
- Unsightly land: Land that shows a serious disregard for general maintenance or upkeep.

In simpler terms, if a property looks neglected, unsafe, or harmful to the enjoyment and value of surrounding properties, it may be considered unsightly.

#### LACOMBE COUNTY'S RULES



Under the County's Land Use Bylaw, property owners are not allowed to keep an unsightly premise if it negatively impacts the enjoyment, value, or character of the surrounding area.

The specific rules depend on what type of area you live in:

#### **Agricultural Areas**

Because farms look different from subdivisions, the County recognizes that equipment and materials related to farming are normal. However, things like garbage piles, unsafe buildings, or dangerous objects on a yard site could be considered unsightly.

#### Residential Subdivisions & Hamlets

Neighbourhoods such as country residential subdivisions, lakeshore communities, and hamlets are held to higher aesthetic standards to maintain their character.

#### That means:

- No sea-containers or tarped structures in view
- No unlicensed or broken vehicles parked in plain sight
- No excessive building materials left out
- Yards and buildings must be kept neat, clean, and in good repair

#### Recreational Vehicle Resort Districts (R-RVR)

Places like Sandy Point RV Resort and Degraff's RV Resort are year-round recreational communities. The same standards as residential areas apply here: no sea-containers, tarped structures, visible debris, or broken vehicles. Yards and buildings should be well-kept.

In addition, each condo development has its own condominium board, which also enforces unsightliness rules alongside the County.

#### **Commercial & Industrial Areas**

In our business and industrial parks, there are specific site development guidelines in place. These regulate things like outdoor storage, screening/fencing, landscaping, signage, and building design. Following these guidelines helps ensure commercial and industrial sites remain functional while still looking presentable.



## Use Fall to Be Prepared for extreme winter weather

Fall is the perfect time to be prepared for the colder months ahead. Use the season change to update your emergency kits, gather supplies, make or update your emergency plans and prepare your home for the winter weather.

Blizzards, ice storms, high winds and blowing snow can develop quickly and threaten life and property. Severe storms occur frequently across Alberta and can be unpredictable when they happen outside of their regular season.

#### **BE PREPARED**

Individuals and families should be prepared to take care of themselves for at least 72 hours. The following steps will assist you in building your preparedness plan.

- Know the risks: Knowing the risks and hazards can help you and your loved ones prepare for the unexpected.
- Make a plan: A plan will help you cope with the stress of an emergency or disaster.
- Build a kit: By taking a few simple steps you can become better prepared to face a range of emergencies. Be sure your kit includes a battery-powered/crank radio/flashlight or Weatheradio in case of a power outage.

Find out where your community will post information and updates during an emergency, and make sure to download the Alberta Emergency Alert app for critical, life-saving alerts.

When individuals are prepared to the best of their ability, this allows first responders, such as police, fire, and ambulance, to focus on the emergency and provide assistance to those who need the help most.

#### **BLIZZARDS AND BLOWING SNOW**

A blizzard warning is issued when falling or blowing snow, combined with 40 km/h winds, is expected for 4 hours or longer. Visibility is usually reduced to 400 metres or less.

A blowing snow advisory is issued when blowing snow combined with 30 km/h winds are expected for 3 hours or longer and visibility is reduced to 800 metres or less.

#### **Blizzard facts**

- Blizzards can occur when there are clear skies.
- In wide open areas, blowing snow or a blizzard can mean zero visibility!

#### **Blizzard survival tips**

- If you live in a rural area and a blizzard or blowing snow is forecast, you may want to string a guideline between your house and any other buildings you might have to go to during the storm.
- Restrict travel to daytime hours and let someone know your route and arrival time.

If you find yourself stuck in a vehicle during a severe storm, remain calm! Stay inside the vehicle, run the engine every once in a while, and beware of fumes. Ensure the exhaust pipe is not blocked, and continually allow fresh air in.

#### FREEZING RAIN AND ICE STORMS

**Freezing rain** is rain that falls through a layer of warm air into a layer of freezing cold air below (below 0°C), freezing onto any surfaces or objects in the cold air and creating a buildup of what is called "glaze ice" on everything it touches.

An ice storm occurs when large amounts of freezing rain continue for several hours. They can also include wind, ice fog, and cold temperatures.

#### Freezing rain and ice storm facts

- Freezing rain can cause damage by creating a heavy load wherever the ice forms. During an ice storm, freezing rain damage can be severe.
- Even a small amount of freezing rain can make roads extremely slippery.
- Ice from freezing rain can build-up on any surface making sidewalks and pathways dangerous for falls and slips.
- In an ice storm, the risks from freezing rain may still be present hours or even days after the rain stops falling.

#### Freezing rain and ice storm survival tips

- Avoid driving when freezing rain is forecast.
- Wait several hours after the storm ends so that road crews have enough time to address poor road conditions.
- If possible, avoid going outdoors. If it's unavoidable, use extreme caution
- Pay attention to wires, large sheets of ice on buildings, tree branches, or power lines above you that could break or fall without warning.
- Never touch a power line you could be electrocuted.

#### **EXTREME COLD**

In Alberta, an extreme cold warning is issued for expectations of air temperature minus 40°C or colder, or the wind chill index is minus 40°C or colder.

#### **Extreme cold facts**

 Temperatures this low could occur throughout the winter months, especially from early December to late February.



- Extreme cold may occur with other weather, such as blizzards, ice storms or ice fog, and pose a risk of hypothermia or frostbite.
- Ice fog can occur in temperatures lower than minus 30°C due to tiny ice particles in the air. Ice fog forms quickly and can reduce visibility to near zero.


#### **Extreme cold survival tips**

- During extreme cold, stay indoors, and try to stay warm.
- If you must go outside, wear proper clothing, and take care not to overexert yourself.

#### FINANCIAL PREPAREDNESS

- Speak to an insurance agent about your specific needs.
- Know your insurance policy. Make sure your home, vehicle, business and belongings are protected.
- If possible, consider an emergency savings account to cover temporary expenses while you are out of your home.
- If you can, keep emergency cash handy in case banking services are unavailable.
- If you are evacuated, keep all receipts for additional expenses.
- Prepare a detailed list of all your belongings.
- Know the 7 steps for making a home insurance claim.

## Halloween safety tips for a safe night

#### **Tips for parents and Caregivers**

Halloween can be an exciting time for children and with the distraction of candy and costumes, safety rules can easily be forgotten. In fact, research shows that distractions can increase a child's chances of being struck by a car. Check out these simple tips to keep Halloween night a safe night for all.

- An adult or responsible older child should accompany younger children since they may lack the developmental skills to cross the street on their own. This is a year-round tip that will help keep your child safe while you share good pedestrian habits and pass on a legacy of safety-minded behaviour.
- 2. Teach your child to stop at the curb, look left, right and left again, and to listen for oncoming traffic. This vital skill is especially important when children are distracted and excited. Never rely on traffic signals alone use your eyes and ears to make sure it's safe to cross.
- 3. It's unsafe to cross between parked cars or other obstacles always cross at crosswalks, street corners or intersections. Many injuries occur when children run out between parked cars, but even at intersections it's vital that children practice tip #2.
- 4. Stay on the sidewalk or path when walking from house to house and if there is no sidewalk, walk beside the road, facing traffic so drivers can see you. From a very young age, children can be taught that roads are for cars and sidewalks are for kids. If your community has no sidewalks, walking beside the road at night can be very

- dangerous adult accompaniment and flashlights are a must, regardless of the child's age.
- 5. Select costumes with bright colours to increase your child's visibility and choose face paint instead of masks.

  Masks can make it hard for your child to see properly and often restrict peripheral vision, making it difficult to check for oncoming traffic before crossing a road.

#### Tips for drivers

Halloween means that there will be more children out on the streets. Drivers need to take extra care.

- Drive slowly in residential areas where children are more likely to be trick-ortreating. Did you know that drivers cannot accurately judge their own speed when driving? The higher the speed, the less likely you are to see a child pedestrian, and the harder it is to stop quickly.
- 2. Watch out for kids, many of whom may be wearing costumes with masks that make it difficult for them to see. With the excitement of Halloween, children may forget simple pedestrian safety rules. They have a tendency to dart out in the most unexpected places the most common being between parked cars. Remember also that costumes can limit a child's vision and they may not be able to see your vehicle.
- Reduce your distractions and stay alert. All your concentration should be on the road, not diverted by cell phones or loud music.
- 4. Remember to enter and exit driveways slowly and carefully. Excited trick-or-treaters may run on sidewalks, or dart out unexpectedly. Proceed with caution, when entering or exiting the roadway.














## ASSESSMENT 101 | What you need to know

## 2025 PROPERTY ASSESSMENT INSPECTIONS

Rotational re-inspections will be wrapping up near the end of October and will resume in the spring of 2026. Property inspections related to annual property changes are ongoing for the remainder of 2025. Lacombe County is aware of new construction and significant renovations due to development and safety codes permitting. We appreciate information provided about buildings where development and/or safety code permits were not requested.

#### **DEMOLITIONS & REMOVALS**

A significant number of demolitions or removals of homes, garages, sheds, or any other buildings were reported to us after the 2025 property tax notices were mailed. Will you assist us in verifying a building has been removed prior to December 31 or it will be assessed and reflected on your 2026 Assessment and Tax Notice. Would you please help us ensure removals are reflected accurately on your property assessment by contacting an Assessor. Assessors leave brightly coloured 'callback' cards when visiting your property to verify property details; please contact the Assessor as requested.

#### **REQUEST FOR COST INFORMATION**

Over the past several months, Lacombe County has requested information related to various projects including validation of property transfers, re inspections, and vacancy/occupancy confirmation.

Requests for information regarding potentially assessable machinery and equipment and/or new construction are due to be mailed. The current postal disruptions have impacted the mailing of these requests. Alternatively, Lacombe County will attempt to mail these via email and forward the hard copies via Canada Post. If you are a nonresidential property owner and have not received an email and have added new (or replaced) improvements to your property, will you please contact the Assessor to provide an email address or alternate means of remitting the information. If you have received a request and require clarification on how to be compliant or what you are being asked to remit, please contact an Assessor one of us will be happy help you.

## COMMUNITY ORGANIZATION PROPERTY TAXATION EXEMPTION (NOT-FOR-PROFIT) APPLICATIONS

The deadline for submitting a COPTER application for the 2026 tax year was September 30, 2025. If you have submitted a COPTER application for the 2026 tax year, will you please submit any outstanding required information by November 30.

#### **NOTICE OF INSPECTIONS**

Lacombe County municipal Assessors are continuously reviewing and visiting properties throughout the municipality as required to verify property information ensuring accurate and equitable assessments – we appreciate your cooperation with data collection activities. ## **Disposing Lithium Batteries DO NOT PLACE IN TRASH!**

## THE RISKS OF IMPROPER LITHIUM BATTERY DISPOSAL

Improper disposal of lithium batteries poses significant risks to both human health and the environment. It is crucial to handle and dispose of these batteries correctly to avoid potential hazards and prevent environmental contamination.

#### LITHIUM BATTERY FIRES

Lithium-ion batteries, if not disposed of properly, can be a fire hazard. LRWSC has had multiple landfill fires in the last six years because of improper battery disposal. These fires can have devastating effects



on human lives, property, and the environment.

#### LITHIUM BATTERY TOXICITY

Apart from the risk of fires, improper disposal of lithium batteries can also result in the release of toxic chemicals. Cobalt, manganese, and nickel are among the dangerous contaminants found in lithium-ion batteries. When these batteries end up in landfills, there is a real danger of these toxic substances seeping into the surrounding soil and groundwater, posing a threat to plant and animal life.

#### LANDFILL CONTAMINATION

Lithium batteries that are thrown into landfills can cause significant environmental contamination. The leakage of hazardous metals such as cobalt, manganese, and nickel can pollute the soil and groundwater. This contamination not only harms the local ecosystem but also increases the risk of underground fires in landfills.

Proper disposal of lithium batteries is vital to mitigate these risks and protect our

health and environment.

By responsibly recycling these batteries, we can prevent fires, reduce toxic chemical exposure, and prevent the contamination of our landfills.

## THE IMPORTANCE OF RECYCLING LITHIUM BATTERIES

Recycling lithium batteries is crucial for the environment and our future. By recycling these batteries, we can prevent the need for new mineral extraction, reducing the negative impact on our planet. This process helps conserve valuable resources and promotes a circular economy where materials are reused rather than discarded.

One of the significant benefits of battery recycling is the recovery of valuable metals and materials. Lithium batteries contain components like cobalt, nickel, and plastic, which can be extracted and reused through recycling. While not all parts of a lithium battery are recoverable, the majority can be recycled, contributing to the conservation of valuable resources.

Recycling lithium batteries also plays a crucial role in reducing the risks

associated with improper disposal. Batteries that end up in landfills can pose threats to the environment and human health. They can leak toxic substances like cobalt, nickel, and manganese, polluting the soil and water sources. Recycling helps prevent these risks and ensures that batteries are disposed of safely.

## HOW TO RECYCLE LITHIUM BATTERIES PROPERLY

Properly recycling lithium batteries is essential to ensure their safe handling and disposal. To start, it's recommended to remove the battery from the device whenever possible. If the batteries are physically damaged, they should be stored in an insulated plastic bag to avoid any short-circuiting. It's important to keep lithium batteries in a cool and dry place to prevent combustion.

LRWSC accepts all batteries at our sites for recycling, please ask the attendant where batteries can be safely placed.

Do NOT place batteries in the Rubble Bins or the Compactor Hopper.



## **WINTER IS COMING! | Winterizing Your Septic Systems**

Did you know that a holding tank or "pumpout" septic system left unused for more than 72 hours may not have the anaerobic bioactivity to generate enough heat to prevent winter freezing? If you plan on using this style of septic system during the winter months, here are some longterm steps needed to protect your system from freezing:

- 1. All components <2.7 meter (9 feet) deep must be insulated with spray or rigid foam to prevent freezing. This foam adds a thermal barrier between frozen ground and nonfrozen ground (frost line). A rough "rule of thumb" is 1 inch of insulation equals 1 foot of ground cover. You always want a minimum of 2.7 m (9 feet) of frost coverage in Alberta!
- Don't forget to insulate the plastic lid of your holding tank. An uninsulated lid can allow heat from bioactivity to escape even

- if the sides and top of the holding tank are insulated. For concrete lids and tops, spray foam applied by a professional can be very effective in preventing heat loss.
- Make sure to use electric heat trace around any piping, check valve or shutoff valve <2.7 meter (9 foot) depth if your system is connected to a communal wastewater system. As these systems DO NOT have a drain hole to empty the pipe between pumping cycles like rural system have. Many are <1 meter (3+ feet ) from the top of the holding tank lid which is in the frost zone.

#### WINTERIZING FOR EXTENDED **HOLIDAYS OR WINTER MONTH ABSENCES**

Clean your holding tank with a garden hose and spray nozzle. Pump down your tank by

> holding the float in the upright position with a long hook on pole. When you see the bottom of the pump, lay the float back down. This process can be done by a professional when they're performing your annual inspection of the pump, valve and check valve.

- 2. Add clean water back into holding tank and ensure pump is submerged in water.
- Add potable RV antifreeze only to the water in the tank, follow manufacturers recommendations for volume and strength.
- Manually run the pump by holding the float in the upright position for a few seconds to circulate RV antifreeze into discharge piping, check valve and service line.
- Leave your holding tank pump active when you're away DO NOT unplug! High efficiency furnaces, dehumidifiers, RO/water softener backwashes, tap/toilet leaks, or even a family member visiting forgetting to let you know can quickly fill or overflow a holding tank with an unplugged pump when you're not there.
- Always leave your alarm system active 24/7 to notify if there's a problem! Some alarm systems have a call out and text feature so you can be immediately notified if there's a problem. Contact your local installer or phone provider to take advantage of this timely benefit.
- Have your daily residence monitor always check for system alarms and water movement in systems not blown out for the
- 8. If you've closed any valves in or after the holding tank, never run a pump with valves closed on the intake or discharge side of your system, this may damage the pump and piping!
